PERSONS IN PAID EMPLOYMENT, BY ACTIVITIES, OCTOBER 2022

In October 2022, the total number of persons in employment in the Republic of Croatia was 1 620 411, out of which 758 471 were women. Compared to September 2022, the total number of persons in employment decreased by 0.1%, while the number of employed women increased by 0.4%. Compared to the same month of the previous year, the total number of persons in employment, as well as the number of employed women, increased by 1.2% in October 2022. In the period from January to October 2022, as compared to the same period of the previous year, the total number of persons in employment increased by 1.4% and the number of employed women by 1.6%.

In October 2022, the total number of persons in paid employment in legal entities in the Republic of Croatia amounted to 1 405 686, out of which 669 081 were women. Compared to September 2022, the number of persons in paid employment in legal entities increased by 0.6% and the number of employed women by 1.1%. The number of persons in paid employment in legal entities in October 2022, as compared to the same month of the previous year, increased by 1.3%, as well as the number of employed women. In the period from January to October 2022, as compared to the same period of the previous year, the number of persons in paid employment in legal entities increased by 1.3% and the number of employed women by 1.6%.

In October 2022, as compared to the previous month, the number of persons in employment in trade and crafts and free lances decreased by 4.5% and the number of employed women by 5.1%. The total number of employed insured persons – private farmers remained at the same level, while the number of employed female farmers decreased by 0.2%.

The total number of unemployed persons increased by 6.0% and the number of unemployed women by 5.5% in October 2022, as compared to September 2022. The total registered unemployment rate in October 2022 was 6.5% and for women it was 7.8%.





NOTES ON METHODOLOGY

Data sources

Data on persons in employment in legal entities were gathered by processing data from the Report on Income, Income Tax and Surtax as well as Contributions for Mandatory Insurances (JOPPD form), which has been in effect since 1 January 2014.

All persons or entities that are the payers of income for which the income tax regulations prescribe the obligation of accounting and paying deduction tax are under the obligation to submit the JOPPD form.

Data on persons in employment in crafts and trades and free lances are processed according to the records on pension insurance beneficiaries obtained from the Croatian Institute for Pension Insurance.

Data on the number of unemployed persons are obtained from the Croatian Employment Service.

Coverage and comparability

The survey on persons in paid employment in legal entities includes all persons who have signed a work contract, regardless of the type of work contract and whether they work full-time or less than full-time.

The survey on persons in crafts and trades and free lances includes owners and employees registered with the Croatian Institute for Pension Insurance.

Definitions

Persons in paid employment are all persons who have signed a work contract with an employer for a fixed or an unspecified period of time, irrespective of the type of ownership and of whether they work full-time or less than full-time.

Registered unemployment rate is calculated as a ratio of the number of unemployed persons to the total active population (labour force).
